

Terms and Conditions

1. The Prize Draw is open only to students of the University of Hertfordshire Higher Education Corporation ("University of Hertfordshire"), who completed the HertSquad Questionnaire 2020 and who provide their email address and accept the terms and conditions after completing the survey.
2. Employees or partner agencies of University of Hertfordshire Higher Education Corporation (including its group partners) or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
3. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions. The University of Hertfordshire reserves the right to refuse entry or refuse to award the prize to anyone in breach of these terms and conditions.

8. The opening date for entries is 00:01 on 11 December 2020. The closing date of the Prize Draw is 23.59 on 23 December 2020. Entries received outside this time period will not be accepted.
9. There are a total of two prizes, 1 x HSV Silver Membership and 1 x £30 Love To Shop Voucher.
10. One winner will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process and the prizes will be allocated in the order set out above. The draw will take place by 11 January 2021.
11. The winner will be notified by email on or before 13 January 2021 and must acknowledge receipt of the email to claim their prize. If a winner does not respond to University of Hertfordshire within 14 days of being notified, then the winner's prize will be forfeited and University of Hertfordshire shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 14 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and University of Hertfordshire shall be entitled to select another winner in accordance with the process described above.
